- A. PUBLIC HEARING ON SECOND READING OF ORDINANCE #12, SERIES OF 2017 (AMENDING SECTIONS 2.16.010(A) AND (B) OF THE YUMA MUNICIPAL CODE TO REDUCE THE SIZE OF THE PLANNING COMMISSION FROM SEVEN MEMBERS TO FIVE MEMBERS) SCOTT MOORE. - B. PUBLIC HEARING ON BREW PUB LIQUOR LICENSE FOR TUMBLEWEED BREWING LOCAL LICENSING AUTHORITY KARMA WELLS. Clerk/Treasurer Wells stated the paperwork has been turned in for a brew pub license for Tumbleweed Brewing. Public hearing was opened. No comments were made. Public hearing was closed. Baucke moved to approve the brew pub liquor license for Tumbleweed Brewing. Second by McCall. Question. 6 ayes. Motion carried.
- C. RESOLUTION #1, SERIES OF 2018 (PERSONNEL POLICY CHANGES) SCOTT MOORE. Manager Moore introduced the resolution and reviewed the drug testing policy, overtime, and a motor vehicle records review policy items with Council. Discussion was held. Swehla moved to approve Resolution #1, Series of 2018. Second by Haag. Question. 6 ayes. Motion carried.
- **D. APPROVAL OF BILLS KARMA WELLS.** Clerk/Treasurer Wells handed out additional lists of bills. Haag moved to approve the bills. Second by Hoch. Question. 6 ayes. Motion carried.

E. PURCHASES IN EXCESS OF \$5,000 – SCOTT MOORE. Manager Moore stated a revised fire alarm proposal was received. The revised proposal is for \$29,996, this is an additional \$12,000 from the original quote. Discussion was held. Haag moved to approve the revised fire alarm proposal. Second by Swehla. Question. 6 ayes. Motion carried.

Manager Moore stated he has found a business to purchase the arms for the stoplights at Second and Main. The quote is for \$14,420.00 for 4 arms. Baucke moved to approve the purchase of the arms for the stoplights. Second by Haag. Question. 6 ayes. Motion carried.

CITY MANAGER, SCOTT MOORE

Manager Moore stated the land at the cemetery is up for lease. Bids are due January 16, 2018, at 5:00 P.M. This is for 120 acres of dryland.
