REGULAR MEETING TUESDAY, MARCH 20, 2018

CALL TO ORDER - 7:30 P.M.

MEETING CALLED TO ORDER BY MAYOR HARPER AND THE PLEDGE OF ALLEGIANCE WAS RECITED.

ACTION ITEMS

- A. PUBLIC HEARING ON SECOND READING ORDINANCE #9, SERIES OF 2018 (AMENDING SECTION 6.04.140 OF THE YUMA MUNICIPAL CODE REGARDING THE DELEGATION OF AUTHORITY OVER THE IMPOUNDMENT OF ANIMALS) SCOTT MOORE. Manager Moore introduced the ordinance. Public hearing was opened. No comments were made. Public hearing was closed. Swehla moved to approve on second reading, Ordinance #9, Series of 2018. Second by Hoch. Question. 4 ayes. Motion carried.
- B. PUBLIC HEARING ON SECOND READING ORDINANCE #10, SERIES OF 2018 (DELETING CHAPTER 12.12, REPEALING AND REENACTING CHAPTER 12.32 AND AMENDING SECTION 15.32.040 REGARDING WORK WITHIN THE PUBLIC RIGHT OF WAY) SCOTT MOORE. Manager Moore introduced the ordinance. The ordinance provides a better way to handle contract work and assessing damages in the right of way. Public hearing was opened. No comments were made. Public hearing was closed. Swehla moved to approve on second reading, Ordinance #10, Series of 2018. Second by Goeglein. Question. 4 ayes. Motion carried.
- C. APPOINTING THE CITY MANAGER PURSUANT TO 6.04.140 SCOTT MOORE. Manager Moore stated this is to appoint the City Manager to manage the dog pound. Swehla moved to appoint the City Manager pursuant to 6.04.140. Second by Goeglein. Question. 4 ayes. Motion carried.

- D. CHANGE DATE OF NEXT COUNCIL MEETING KARMA WELLS. This item was accidentally skipped during the meeting.
- **E. APPROVAL OF BILLS KARMA WELLS.** Clerk/Treasurer Wells provided Council with an additional list of bills. Hoch moved to approve the bills. Second by Swehla. Question. 4 ayes. Motion carried.
- **F. PURCHASES OVER \$5,000 SCOTT MOORE.** Manager Moore requested approval of the yearly contract for the AWOS maintenance, which provides weather information to pilots at the airport. The cost of the maintenance is \$5,045. Hoch moved to approve the AWOS maintenance for \$5,045. Second by Goeglein. Question. 4 ayes. Motion carried.

Manager Moore also requested approval of the purchase of a transformer for the new Bank of Colorado location for \$13,719.57 from Border States Supply. This purchase will be reimbursed by the Bank of Colorado. Swehla moved to approve the transformer purchase from Border States for \$13,719.57. Second by Hoch. Question. 4 ayes. Motion carried.
