ACTION ITEMS

- A. PUBLIC HEARING ON SPECIAL EVENTS PERMIT FOR WEST YUMA COUNTY CHAMBER OF COMMERCE LOCAL LICENSING AUTHORITY, KARMA WELLS. Clerk/Treasurer Wells stated the Chamber would like to have a business after hours event at Viaero on May 17, 2018, from 5-7 P.M. Public hearing was opened. No comments were made. Public hearing was closed. Swehla moved to approve the Special Events Permit for the West Yuma County Chamber of Commerce. Second by McCall. Question. 7 ayes. Motion carried.
- B. LIQUOR LICENSE RENEWAL FOR PAPER MOON ENTERTAINMENT LLC LOCAL LICENSING AUTHORITY, KARMA WELLS. Clerk/Treasurer Wells stated all the paperwork has been turned in to renew the liquor license for Paper Moon Entertainment LLC. Manager Moore stated this is for a building west of the Street Department Shop that staff would like to rent to store more equipment. This would help clean up the Street Department Shop area. - **G. PURCHASES IN EXCESS OF \$5,000 SCOTT MOORE.** Manager Moore requested approval of a purchase from Arnold Pool Company for chlorine briquettes in the amount of \$5,160.20. Swehla moved to approve the purchase from Arnold Pool Company for \$5,160.20. Second by Goeglein. Question. 7 ayes. Motion carried.
