The second request is for the material for the sewer line replacement project. Two quotes were received.Dana Kepner\$10,957.74Core and Main\$10,732.42Hoch moved to approve the quote from Core and Main for \$10,732.42. Second by Chrismer. Question. 5ayes. Motion carried.

Manager Moore requested approval of the roofing repairs at City Hall from the hail storm last year. The quote was from Grabau Roofing for \$175,608. There is a 15 year warranty on the roof. Goeglein moved to approve the quote from Grabau Roofing. Second by Chrismer. Question. 5 ayes. Motion carried.

There are several roofs needing repaired from hail last year. Mr. Jeff Pagel is going to do some of these roofs. The total quote from Mr. Pagel for the roofs he is doing is \$45,287.00 Mr. Pagel would like half the payment to start the roofs, that would amount to \$22,643. Hoch moved to approve the payment of \$22,643 to Jeff Pagel for ½ the roof repairs. Second by Goeglein. Question. 5 ayes. Motion carried.
