State law has requirements for changing speed limits. An investigation or a study should be done on that street before the speed limit is changed. Attorney Sellars also mentioned to increase enforcement on this street to try to help with speeds. Discussion was held. It was mentioned that stop signs can be put up in that area to help with speeds. Chief Lynch and Manager Moore will work on the issue.
