### **CITY MANAGER, SCOTT MOORE**

Manager Moore was approached by the Grand Lodge about doing a cornerstone in the building in April 2020.

The generator installation for City Hall has started and will hopefully be completed in 2 weeks.

The Police Department had gotten approval to purchase 2 patrol cars. Just to clarify the cost, the vehicles will be \$38,100 each and the up-fitting for the cars will be \$14,572 each.

The Police Department also received a JAG Grant for tablets in the patrol cars. The tablets should be installed soon.
