(Continued from Council meeting on November 7, 2017) CONSIDERATION OF <u>REVISED</u> ORDINANCE #8, SERIES OF 2017 (REPEALING AND REENACTING SECTIONS 6.04.010, 6.04.030, 6.04.035, 6.04.050, 6.04.070, 6.04.080, 6.04.190, 6.04.220, 6.04.210, AMENDING SECTIONS 6.04.100, 6.04.130, 6.04.150, 6.04.160, DELETING SECTIONS 6.04.090, 6.04.120, 6.04.205, 6.04.230, 6.04.240, 6.04.250, 6.04.260, 6.04.270 AND AMENDING CHAPTER 6.04 BY THE ADDITION TO NEW SECTIONS 6.04.170 AND 6.04.180, ALL REGARDING ANIMAL REGULATION) – SCOTT MOORE. - B. RESOLUTION #22, SERIES OF 2017 (REPLACEMENT OF THE FPPA DEFERRED COMPENSATION PLAN AND ADOPTION OF THE FPPA MULTI-EMPLOYER DEFERRED COMPENSATION PLAN) – KARMA WELLS. Clerk/Treasurer Wells introduced the resolution. Swehla moved to approve Resolution #22, Series of 2017. Second by Baucke. Question. 5 ayes. Motion carried.
- C. RESOLUTION #23, SERIES OF 2017 (AMENDMENT TO FLEXIBLE SPENDING ACCOUNT) KARMA WELLS. Clerk/Treasurer Wells explained the IRS limit has changed for flexible spending

accounts to a maximum of \$2,650 per year, therefore we are asking to make the change to what is allowed by the IRS. Haag moved to approve Resolution #23, Series of 2017. Second by Hoch. Question. 5 ayes. Motion carried.

- D. RESOLUTION #24, SERIES OF 2017 (AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT WITH JAMES H. PEDERSEN CONCERNING THE YUMA COMPREHENSIVE PLAN UPDATE) – SCOTT MOORE. Manager Moore stated this is to amend the agreement with Pedersen Planning Consultants to implement and include the changes from the November 28 meeting. We are extending the contract in time only. Haag moved to approve Resolution #24, Series of 2017. Second by Swehla. Question. 5 ayes. Motion carried.
- E. FIRST READING ORDINANCE #9, SERIES OF 2017 (ADOPTING THE 2018 BUDGET AND APPROPRIATING SUMS OF MONEY) – KARMA WELLS. Clerk/Treasurer Wells introduced the ordinance. A correction was noted on the Conservation Trust Fund in the ordinance. Manager Moore reviewed changes made to the budget from the workshops. Discussion was held. Harper moved to approve on first reading Ordinance #9, Series of 2017. Second by Swehla. Question. 5 ayes. Motion carried.
- F. FIRST READING ORDINANCE #10, SERIES OF 2017 (SETTING THE MILL LEVY FOR THE BUDGET YEAR 2018) – KARMA WELLS. Clerk/Treasurer Wells introduced the ordinance. Haag moved to approve on first reading Ordinance #10, Series of 2017. Second by Hoch. Question. 5 ayes. Motion carried.
- G. FIRST READING ORDINANCE #11, SERIES OF 2017 (AMEND THE 2017 BUDGET) KARMA WELLS. Clerk/Treasurer Wells reviewed the ordinance with Council amending the Reserve/Capital Projects Fund, Debt Service Fund, and the Ambulance Fund. Swehla moved to approve on first reading Ordinance #11, Series of 2017. Second by Haag. Question. 5 ayes. Motion carried.
